## MINUTES June 20, 2006

### Call to Order

Chairwoman Betty Seidel called the meeting to order at 9:05 a. m., Tuesday, June 20, 2006 in the office of the Danville Election Commission. Those in attendance were Commissioners Betty Seidel and Barbara Bailey, Executive Director Barbara Dreher and Attorney Dave Ryan. Commissioner Charles Bostic was absent.

### Approval of Agenda

Betty Seidel moved to accept the agenda as presented. Seconded by Barbara Bailey. Motion was carried.

### Approval of Minutes

Barbara Bailey moved to approve the minutes of May 16, 2006 meeting as submitted. Seconded by Betty Seidel. Motion was carried.

### Accounts Payable – Purchase orders

Barbara Dreher explained purchase orders in the total amount of \$1,839.91. Barbara Bailey moved to approve the purchase orders for payment. Seconded by Betty Seidel. Motion was carried.

### Legal Update

Attorney Dave Ryan updated the Commission on the Newell Township recount. He stated that as of the date of this meeting the final mandate had not been received. Therefore, the Commission is still waiting for further direction from the court.

### Precinct Polling Place Changes

Following discussion Commissioners approved the change of location for Precinct #17 from the Nazarene Church to the Gao Grotto on Denmark Road. This keeps Precinct #17 within the boundaries. Request to change the location of Precinct #27 from the #2 Fire Station to the Nazarene Church was denied.

### Voter Registration System

Barbara Dreher gave an update on a new VEMACS voter registration system. She stated that she had visited Douglas County to see their system and felt that it had a number of very good features that would meet our needs and state requirements. Betty Seidel asked that she establish a date with the vendor representative to give a presentation in the near future with the Commissioners.

**2006-2007 Budget Update**

The 2006-2007 Budget changes were presented and reviewed. Barbara Dreher explained the changes and after discussion it was decided to have some additional cuts and send revised copies to the Commissioners for review prior to the County Board Committee meeting.

**Activities with County Clerk**

Barbara Dreher reported that she is coordinating registration activities with the County Clerk for the November Election. Posters for both offices will be made at a low cost.

**General Election Ballot**

Discussion was held regarding the signature required for the November General election official ballot. There is a possibility that the Executive Director will not have her signature on the ballot. This matter is under advisement with the AECOI and will be discussed at the July meeting.

**County Tax & Election Meeting**

Tax and Election Committee Meeting is scheduled for June 27<sup>th</sup>, 2006 at 5:15 p.m. on the third floor of the Courthouse Annex.

No further business, meeting was adjourned to Tuesday, July 18, 2006 at 9:00 a.m.
