MINUTES OF REGULAR MEETING July 8, 2008

Call to Order

The monthly meeting of the Danville Election Commission was called to order at 8:56 a.m. on Tuesday, July 8, 2008 by Chairman Barbara Bailey in the office of the Election Commission. Present were Commissioners Barbara Bailey, Charles Bostic, Everett L. Laury, and Assistant Executive Director, Jessica Sampson.

Minutes and Agenda

The Minutes of the last regular meeting of June 10, 2008 and the agenda for the present meeting were unanimously approved by the Commissioners.

Itemized Bills of the Commission

Itemized bills of the Election Commission totaling \$868.70 were unanimously approved by the Commissioners.

Voter Registration

Total new registrations of 142 were reported by Jessica Sampson, the total down from the previous month. The total registered voters now in the City of Danville are 17,100.

Legislation

No new legislation has been reported since the legislature has not been in session.

Election Judges

Each election judge has received a C.D. from Executive Director, Barbara Dreher, outlining the responsibilities of a judge. Also, classes for the training of the judges have been scheduled on eleven separate dates from July 29, 2008 through August 9, 2008 for which the judge will choose a session to attend. At the session the judge will get instructions as to use of the computer at the polling place. The classes will be held in the meeting room on the second floor of the Courthouse Annex. Each Commissioner has agreed to attend at least one of the training sessions.

Hava Grant Update

Information on the Ballot on Demand has been requested but has not yet arrived. Purchase of 5 laptops computers under the grant was discussed and the Commission favored those purchases over a palm computer. Also discussed were extra M-100 Units. We have now 4 such units for early voting. Also discussed were the need for a better color laser than the one we have now, and also the need for a new barcode scanner.

Other Matters Discussed

There will be two additional election judges used to work the early voting and absentee voting locations outside the election commission office, to be used during the normal weekday hours and also on Saturdays. Mention was made of the next County Board Finance Committee Meeting scheduled for August 1, 2008 at a time to be announced.

Next Meeting and Adjournment

The meeting was adjourned at 9:38 a.m. with the next meeting scheduled for 9:00 a.m. on Tuesday, August 12, 2008.
