## MINUTES OF THE REGULAR MEETING

July 13, 2010

### Call to Order, Agenda and Minutes:

A regular meeting of the Danville Election Commission was called to order by Chairman and Commissioner Barbara Bailey at the Commission offices at 9:00AM on Tuesday, July 13, 2010. Also present was Commissioner Everett Laury and Executive Director Barbara Dreher. The proposed agenda and minutes of the June 8, 2010 meeting were unanimously approved.

### Accounts Payable and Budget Matters:

The payables report for June 1 to July 6, 2010 was unanimously approved, in the amount of \$2084.31 for election spending. Also unanimously approved were budget line transfers of \$2000.00 from the canvass line and \$2125.00 from the legal fees line, both to go into the part time employee line. In addition, approved was the transfer of \$5000.00 from the postage line to the election personnel line.

### Voter Registration:

Director Dreher reported 315 registrations received during June 2010, of which 147 were new registrations, 79 were transfers, and 78 were not accepted since they were duplicates received from the local Public Aid or Motor Vehicle Offices. A discussion was had as to why there was routinely a large number of duplicates from Public Aid.

### IACREOT Conference:

Commissioner Bailey reported on the recent IACREOT conference in Chicago that she attended. This was an international conference with election personnel attending from the United States and many other countries. We received brochures on the latest in election voting and vote processing equipment, and heard different ways in which other jurisdictions, both in our country and outside, conducted their elections.

### Election Judge Training:

Director Dreher reported that a training school for our Danville judges will be held on July 21, 22, 28, 29 and 31, and also on Aug. 3, 4 and 5. It appears that we will have enough judges for the November Election, but we can use a few more Republican judges.

### Assistant Director Search:

It was reported that we have 7 written applications for the vacant Assistant Director position. We are still taking applications. It was agreed in the near future the Director and Board will conduct interviews of the applicants.


### Other Matters:

A registration booth will be set up on August 21, 2010 at the Allen Chapel AME Church in Danville.

### Adjournment:

The meeting was adjourned at 10:20AM. The next regular meeting is scheduled for 9:00AM, Tuesday, August 10, 2010.
