2. Completely prepares and defends all types and kinds of misdemeanor and traffic offenses.
3. Exercises administrative responsibility under general supervision and exchanges information with social service agencies and the judiciary concerning the docketing of all criminal misdemeanor and traffic cases.
4. Under the direct supervision of a more experienced Defender, participates in all types of criminal felony defenses and juvenile proceedings; including legal research, representation of the defendant at pre-trial hearings, preparation for trial, and the trial.
5. Under the direct supervision of a more experienced Defender, participates in the preparation of written briefs and oral arguments in criminal felony and juvenile proceedings.
