IMPORTANT CITATION NOTICE

The **Respondent** is hereby prohibited from making or suffering any transfer or other disposition of or interfering with any property not exempt from execution or garnishment belonging to you, or to which you may be entitled or which may hereafter be acquired by you or become due to you.

YOU are prohibited from paying over or otherwise disposing of any monies not exempt which are due or which become due until further order of this Court.

IF YOU, THE RESPONDENT, VIOLATE THIS CITATION, THE COURT MAY PUNISH YOU FOR CONTEMPT OF ITS ORDERS.

YOU are informed that money and property from some sources or up to certain amounts may not be taken from you. These funds are protected under Federal and State Laws. Money or property which may not be taken is called "exempt" property. Exempt property includes the following:

1. Social Security and SSI benefits;
2. Welfare benefits (AFDC, AABD, General Assistance, Public Assistance benefits, including food stamps and TANF);
3. Certain life insurance proceeds;
4. Workers Compensation awards;
5. Unemployment Compensation awards;
6. Veterans benefits;
7. Circuit Breaker Property Tax Relief benefits;
8. Certain alimony and support payments;
9. Certain pension and retirement benefits;
10. Certain payments on account of bodily injury or wrongful death;
11. \$4,000 (equity value) of personal property, as chosen by you, including bank accounts;
12. \$2,400 (equity value) of any one motor vehicle;
13. Under Illinois law, the amount of wages that may be applied toward a Judgment is limited to the lesser of (i) 15% of gross weekly wages or (ii) the amount by which disposable earnings for a week exceed the total of 45 times the federal minimum hourly wage or, under a Wage Deduction Summons served on or after January 1, 2006, the minimum hourly wage prescribed by Section 4 of the Minimum Wage Law, whichever is greater;
14. \$1,500 (equity interest) in Respondent's tools of the trade, professional books or implements;
15. \$15,000 homestead exemption in a residence which is owned and occupied by the Respondent;
16. Under Federal Law, the amount of wages that may be applied toward a Judgment is limited to the lesser of: (i) 25% of disposable earnings for a week or (ii) the amount by which disposable earnings for a week exceed 30 times the federal minimum hourly wage.
17. The Respondent may have other possible exemptions under the law.

THE RESPONDENT HAS THE RIGHT AT THE CITATION HEARING TO DECLARE EXEMPT CERTAIN INCOME OR ASSETS OR BOTH. If you think that your income or property is exempt, and if you have any questions about your exemptions, you should take this paper to a lawyer at once. A lawyer can advise you more specifically of your rights. If you cannot afford a private attorney, there is the Land of Lincoln Legal Assistance Program (217-356-1351).

The court date specified on the front page of this Citation is the date set for you to tell the Judge if you have an exemption. **IF YOU DO NOT GO TO COURT ON THE DATE AT THE TIME SCHEDULED ON THE FRONT PAGE OF THIS CITATION, A BENCH WARRANT MAY BE ISSUED FOR YOUR ARREST.**
