

ORDINANCE

RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR VERMILION COUNTY FOR THE 2014-2015 FISCAL YEAR – HEALTH DEPARTMENT (FUND 003)

WHEREAS, the Affordable Care Act requires everyone to have insurance, which has resulted in changes to both patients and providers, to how various health services are provided and funded; and

WHEREAS, the Health Department is now mandated to purchase and maintain an inventory of various vaccines to be administered, and then the various insurance companies be billed for reimbursement, rather than the vaccines be provided by the state through the Vaccines for Children (VFC) program as previously done; and

WHEREAS, estimates have been made for revenue and cost based on historical numbers of immunizations given to Medicaid patients in the past, and

WHEREAS, the requirement to maintain this inventory and bill insurance companies for payment, as well as the cost of the vaccines, and revenue from administering the same were not known at the time the budget was prepared, and thus not included; and

WHEREAS, these amounts must now be budgeted in the FY 2014-2015 budget in order for these vaccines to be purchased as mandated by the Affordable Care Act;

NOW, THEREFORE BE IT ORDAINED by the County Board of Vermilion County Illinois that the County Auditor be authorized and instructed to amend the budget for fiscal year 2014-2015 by appropriating the sum of SEVENTY FIVE THOUSAND DOLLARS AND NO/CENTS (\$75,000) as follows:


And the totals be adjusted accordingly.


