

**ORDINANCE**

**RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR VERMILION COUNTY FOR THE 2014-2015 FISCAL YEAR – GENERAL FUND / EMA**

**WHEREAS**, Vermilion County is acting as a pass-through facility for funding for development of a DMA2K Mitigation Plan; and

**WHEREAS**, a check has been received and deposited from the State of Illinois in the amount of \$5,768.82, and must now be paid to Southern Illinois University under the terms of the program; and

**WHEREAS**, the full amount to be received and the timing of such was unknown at the time the budget was prepared, and so was not included in the 2014-2015 Fiscal Year budget; and

**WHEREAS**, these amounts must now be budgeted in the FY 2014-2015 budget in order for these funds to be now be paid out thus creating an emergency situation;

**NOW, THEREFORE BE IT ORDAINED** by the County Board of Vermilion County Illinois that the County Auditor be authorized and instructed to amend the budget for fiscal year 2014-2015 by appropriating the sum of FIVE THOUSAND SEVEN HUNDRED SIXTY EIGHT DOLLARS AND EIGHTY TWO CENTS (\$5,768.82)as follows:


And the totals be adjusted accordingly.


