

ORDINANCE

RE: REVISION OF THE VERMILION COUNTY HEALTH DEPARTMENT'S PRIVATE SEWAGE DISPOSAL PROGRAM FEE SCHEDULE

WHEREAS, the County Board of Vermilion County, Illinois did, on August 12, 1991 adopt an amended ordinance governing private sewage disposal in Vermilion County, and,

WHEREAS, the County Board of Vermilion County, Illinois did most recently, on September 13, 2005 adopt an ordinance to establish a revised fee schedule which included a fee of \$150.00 for private sewage disposal system construction permits pursuant to a Board of Health recommendation; and,

WHEREAS, the Vermilion County Board of Health did on May 19, 2015, recommend increasing the private sewage disposal system construction permit fee to \$200.00 due to increased service costs and because the revenues projected for the Vermilion County Health Department's 2015/2016 fiscal year budget request is dependent on this increase; and

WHEREAS, the County Board of Vermilion County, Illinois did most recently, on August 16, 2005 adopt an ordinance to establish a revised fee schedule which included a fee of \$150.00 for home loan sewage-system inspection pursuant to a Board of Health recommendation; and,

WHEREAS, the Vermilion County Board of Health did on May 19, 2015, recommend increasing the home loan sewage-system inspection fee to \$200.00 due to increased service costs and because the revenues projected for the Vermilion County Health Department's 2015/2016 fiscal year budget request is dependent on this increase; and

WHEREAS, the County Board of Vermilion County, Illinois did, on November 13, 1984 adopt an ordinance governing a sewage contractor license fee in Vermilion County, and,

WHEREAS, the Vermilion County Board of Health did on May 19, 2015, recommend increasing the contractor license fee to \$75.00 due to increased staffing costs and because the revenues projected for the Vermilion County Health Department's 2015/2016 fiscal year budget request is dependent on this increase.

NOW THEREFORE BE IT ORDAINED, that the County Board of Vermilion County, Illinois hereby approves the following fee schedule:

Private Sewage Disposal System Permits	\$200.00
Home Loan Sewage-System Inspection Fee	\$200.00
Sewage Contractor License Fee	\$75.00

to be effective December 1, 2015.
