RE: REVISION OF VERMILION COUNTY HEALTH DEPARTMENT'S WATER WELL FEE STRUCTURE

WHEREAS, the County Board of Vermilion County, Illinois did, on September 12, 1989, adopt an ordinance governing potable water wells and water supplies, and

WHEREAS, the Vermilion County Board of Health did, on May 19, 2015, recommend increasing the potable water well construction or deepening permit fee to \$150.00 due to increased service costs and because the revenues projected for the Vermilion County Health Department's 2015/16 fiscal year budget request is dependent on this increase, and

WHEREAS, the Vermilion County Board of Health did, on May 19, 2015, recommend increasing the well-sampling fee associated with home-loan inspections to \$75.00 due to increased service costs and because the revenues projected for the Vermilion County Health Department's 2015/16 fiscal year budget request is dependent on this increase.

WHEREAS, the Vermilion County Board of Health did, on May 19, 2015, recommend increasing the well-resampling fee associated with home-loan inspections to \$35.00 due to increased service costs and because the revenues projected for the Vermilion County Health Department's 2015/16 fiscal year budget request is dependent on this increase, and

WHEREAS, the Vermilion County Board of Health did, on May 19, 2015, recommend charging out-of-state residents a \$35.00 fee to process their water samples due to increased service costs and because the revenues projected for the Vermilion County Health Department's 2015/16 fiscal year budget request is dependent on this increase.

NOW THEREFORE BE IT ORDAINED, that the County Board of Vermilion County, Illinois hereby approves the following fee schedule :

Potable Water Well Construction or Deepening Permits	\$150.00
Home-Loan Inspection Well-Sampling Fees	\$75.00
Home-Loan Inspection Well-Resampling Fees	\$35.00
Out-Of-State Well-Sample Processing Fees	\$35.00

To be effective December 1, 2015.
