ORDINANCE

Re: VITAL RECORDS BIRTH REGISTRATION FEES FOR THE LOCAL REGISTRAR, VERMILION COUNTY HEALTH DEPARTMENT

WHEREAS, the Vital Records Ace, ILCS, Chapter 410, paragraph 532/25 specifies that local vital records registrars may charge fees that do not exceed the fee rates charged by the State Registrar for record searches and certified copies; and,

WHEREAS, the State Registrar and local registrars charge a fee of up to \$25.00 for a combined birth record search and the first certified copy requested for each record search and \$11.00 for each additional certified copy; and,

WHEREAS, the Local Registrar/Vermilion County Health Department has only been charging a combined total of \$12.00 for each record search and the first certified copy for each request and \$2.00 for each additional certified copy as last revised by a county ordinance on August 11th, 1998; and,

WHEREAS, the Local Registrar/Vermilion County Health Department has incurred significantly increased costs for the forms and supplies required to implement the new Illinois Electronic Birth Registration System, the Vermilion County Board of Health has recommended a vital records birth record fee increase as follows:

WHEREAS, the Vermilion County Board of Health has recommended a local vital records birth registration fee increase as follows:

- \$14.00 for each combined birth record search and first certified copy
- \$ 4.00 for each additional certified birth record search

NOW, THEREFORE BE IT ORDAINED by the Vermilion County Board, effective on December 1, 2015, that the fee schedule for certified copies of birth records issued by the Local Registrar/Vermilion County Health Department shall be revised as follows:

- \$14.00 for each combined birth record search and first certified copy
- \$ 4.00 for each additional certified birth record search
