

ORDINANCE

Re: VITAL RECORDS DEATH REGISTRATION FEES FOR THE LOCAL REGISTRAR, VERMILION COUNTY HEALTH DEPARTMENT

WHEREAS, the Vital Records Act, ILCS, Chapter 410, paragraph 532/25 specifies that local vital records registrars may charge fees for death record searches and certified copies; and,

WHEREAS, local registrars charge a fee of up to \$29.00 for a combined death record search and the first certified copy requested for each record search and \$14.00 for each additional certified copy requested for each record search; and,

WHEREAS, the Local Registrar/Vermilion County Health Department has not increased the local death registration and copying fees since December 1, 2008 and has only been charging a combined total of \$14.00 for the each death record search for the first certified copy for each request and \$4.00 for each additional certified copy, plus the additional cost charged by the State of Illinois per copy which is collected by the Vermilion County Health Department and remitted to the State of Illinois, as last revised by a county ordinance on June 10, 2008; and,

WHEREAS, the Local Registrar/Vermilion County Health Department has incurred significantly increased costs for the forms and supplies required to implement the new Illinois Electronic Death Registration System; and,

WHEREAS, the Vermilion County Board of Health has recommended a local vital records death registration fee increase as follows:

\$16.00 for each combined death record search and first certified copy

\$ 6.00 for each additional certified death record search

NOW, THEREFORE BE IT ORDAINED by the Vermilion County Board, effective on December 1, 2015, that the fee schedule for certified copies of death records issued by the Local Registrar/Vermilion County Health Department shall be revised as follows:

\$16.00 for each combined death record search and first certified copy

\$ 6.00 for each additional certified death record search
