Re: Raffle/Poker Run Amendment

WHEREAS, the County Board recently passed an ordinance relating to the issuance of raffle and poker run licenses: and

WHEREAS, the volume of such requests cannot be satisfied by limiting approval to monthly meetings due to timing issues; and

WHEREAS, such events serve important social and community needs; and

WHEREAS, a change as set forth below would satisfy both the state law and the need to process such raffle licenses.

NOW, THEREFORE BE IT ORDAINED that the Ordinance relating to Poker Runs and Raffle Licenses is amended as follows. Said amendment to be effective immediately:

(D) In order to obtain a license under this section, the applicant must pay to the County a license fee of \$10 for each application. Licenses issued pursuant to this section shall be valid for one raffle or for a specified number of raffles to be conducted during a specified period not to exceed one year. Any license issued hereunder may be suspended or revoked by the County Board Chairman for any violation of this section. *Upon submission of the application with the required fee, said license shall be reviewed by the Finance Chairman and/or the County Board Chairman and, if approved, then issued by the Finance Chairman and/or the County Board Chairman, countersigned by the County Clerk. All approvals of licenses shall be reviewed at the next available County Board meeting.* ~~The County Board shall act on properly completed and filed license applications within 30 days from the date of application. No license under this section shall be issued without approval of the County Board.~~
