

**ORDINANCE**

**RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR VERMILION COUNTY FOR THE 2014-2015 FISCAL YEAR – CAPITAL IMPROVEMENTS FUND**

**WHEREAS**, plans to renovate and repair various County owned buildings with the funds received through the sale of the Nursing Home and Farm Land have been progressing; and

**WHEREAS**, numerous repairs have been completed this year including large projects at the Animal Shelter, Health & Education Building, and other initiated and in progress; and

**WHEREAS**, additional expenses are expected to be incurred as the County is continuing to make the necessary improvements/repairs on our buildings; and

**WHEREAS**, the expense of these needs were unknown and unplanned for at the time the budget was prepared, and thus funding was omitted, therefore, creating an emergency situation.

**NOW, THEREFORE BE IT ORDAINED** by the County Board of Vermilion County, Illinois that the County Auditor be authorized and instructed to amend the budget for fiscal year 2014-2015 by appropriating the sum of EIGHT HUNDRED FIFTY THOUSAND DOLLARS AND NO CENTS (\$850,000) as follows:

041.910.00.04525	Capital Improvements	\$850,000


And the totals be adjusted accordingly.


