## **ORDINANCE**

## RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR VERMILION COUNTY FOR THE 2014-2015 FISCAL YEAR — ANIMAL REGULATION FUND

WHEREAS, the Department on Animal Regulation was directed by their Veterinarian with a second opinion from another local vet, to seize several horses and other animals that were abused; and

WHEREAS, these animals must now be cared for involving Veterinarian care, food and boarding until the legal case against the owners proceeds through court; and

WHEREAS, this money may be recovered through the legal proceedings, this will not be prior to the end of the 2014-2015 fiscal year; and

WHEREAS, knowledge of the situation was not known at the time the budget was prepared, and so was not included in the 2014-2015 Fiscal Year budget, thus creating an emergency situation; and

WHEREAS, these amounts must now be budgeted in the FY 2014-2015 budget in order for these funds to provide services required by law in this situation;

**NOW, THEREFORE BE IT ORDAINED** by the County Board of Vermilion County Illinois that the County Auditor be authorized and instructed to amend the budget for fiscal year 2014-2015 by appropriating the sum of FOURTEEN THOUSAND DOLLARS AND ZERO/CENTS (\$14,000) as follows:
