

ORDINANCE

**RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION
ORDINANCE FOR VERMILION COUNTY FOR THE 2015-2016 FISCAL YEAR – LAW
ENFORCEMENT FUND AND GENERAL FUND**

WHEREAS, various scenarios were tried when setting the budget, including moving the payroll for the Deputies to the Law Enforcement Fund; and

WHEREAS, it was decided the payroll expense was best if it was left in the General Fund, Sheriff's Department budget; and

WHEREAS, in the process 3 lines were overlooked, and were not put in the General Fund budget with the rest of the payroll lines; and

WHEREAS, these amounts must now be adjusted in the FY2015-2016 budget in order for payroll expenses to be in the same budget.

NOW, THEREFORE BE IT ORDAINED by the County Board of Vermilion County Illinois that the County Auditor be authorized and instructed to amend the budget for fiscal year 2015-2016 by reducing the appropriation in the Law Enforcement Fund the sum of FORTY THREE THOUSAND SEVEN HUNDRED FIFTY DOLLARS AND NO/CENTS (\$43,750), and increasing the appropriation in the General Fund the same amount (\$43,750) as follows:
