

ORDINANCE

**RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION
ORDINANCE FOR COUNTY CLERK'S OFFICE**

WHEREAS, the County Board has been advised that election workers should be paid out of the salary line rather than contractual; and

WHEREAS, additional funds for the salary line is required and can be achieved by transferring funds from the County Clerk's Contractual line to Election Personnel; and

WHEREAS, the budget therefore needs to be amended to take money from the Contractual line and place it in the Election Personnel line, and was not known when the budget was prepared, and thus was not included.

NOW, THEREFORE BE IT ORDAINED by the County Board of Vermilion County Illinois that the County Auditor be authorized and instructed to amend the budget for fiscal year 2016-2017 by transferring the lines as set out:
