RE: RESOLUTION FOR COUNTY ENGINEER'S SALARY SECTION: 15-00000-01-CS

WHEREAS, the County has sufficient Surface Transportation Program funds available and desires to use a portion of said funds to pay a portion of the County Engineer's salary, and,

WHEREAS, the County desires to appropriate funds for the purpose of payment of the County Engineer's salary for the period beginning June 16, 2015 and ending June 16, 2016.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Vermilion County, that the sum of One Hundred Thirty Nine Thousand Seven Hundred Twenty One Dollars (\$139,721) be hereby appropriated for payment of the County Engineer's salary. Said appropriation includes Fifty Five Thousand One Hundred Fifty Dollars (\$55,150) for salary and Twenty Nine Thousand Four Hundred Twenty One Dollars (\$29,421) for FICA, IMRF, Insurance and Travel Expenses from the County Motor Fuel Fund and Fifty Five Thousand One Hundred Fifty Dollars (\$55,150) for salary from the County's Surface Transportation Program fund.

BE IT FURTHER RESOLVED that the County hereby authorizes the sum of Fifty Five Thousand One Hundred Fifty Dollars (\$55,150) of their Surface Transportation Program funds to be made available to the Illinois Department of Transportation for the State's use in exchange for an equal amount of State funds. The State funds shall equal fifty percent (50%) of the County Engineer's annual salary.

BE IT FURTHER RESOLVED that two (2) certified copies of this Resolution be mailed to the Illinois Department of Transportation through its Region Engineer, Paris, Illinois and one (1) certified copy to the Vermilion County Highway Department.
