The resolution authorizing the transfer of \$55,700.00 of Surface Transportation Program (STP) funds for partial reimbursement of the Vermilion County Engineer's salary was approved by the department on August 11, 2016.

A warrant in the amount of the STP transfer will be issued to the County Treasurer and mailed to you by the State Comptroller's office in the near future. This warrant should be deposited in the county's Motor Fuel Tax account. We have assigned a section designation of 17-CS183-00-AC for use in monitoring the fund transfer. The section designation identifies the year "17" of the transfer, the "CS" indicates the transfer is for County Engineer's salary, "183" is your county number, and the "AC" identifies it as a credit to the county's Motor Fuel Tax account.

RE: RESOLUTION FOR COUNTY ENGINEER'S SALARY
SECTION: 16-00000-01-CS

WHEREAS, the County has sufficient Surface Transportation Program funds available and desires to use a portion of said funds to pay a portion of the County Engineer's salary, and,

WHEREAS, the County desires to appropriate funds for the purpose of payment of the County Engineer's salary for the period beginning June 16, 2016 and ending June 16, 2017.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Vermilion County, that the sum of One Hundred Forty One Thousand One Hundred Dollars (\$141,100) be hereby appropriated for payment of the County Engineer's salary. Said appropriation includes Fifty Five Thousand Seven Hundred Dollars (\$55,700) for salary and Twenty Nine Thousand Seven Hundred Dollars (\$29,700) for FICA, IMRF, Insurance and Travel Expenses from the County Motor Fuel Fund and Fifty Five Thousand Seven Hundred Dollars (\$55,700) for salary from the County's Surface Transportation Program fund.

BE IT FURTHER RESOLVED that the County hereby authorizes the sum of Fifty Five Thousand Seven Hundred Dollars (\$55,700) of their Surface Transportation Program funds to be made available to the Illinois Department of Transportation for the State's use in exchange for an equal amount of State funds. The State funds shall equal fifty percent (50%) of the County Engineer's annual salary.

BE IT FURTHER RESOLVED that two (2) certified copies of this Resolution be mailed to the Illinois Department of Transportation through its Region Engineer, Paris, Illinois and one (1) certified copy to the Vermilion County Highway Department.
