**Re: Deletion of CH 18 from County Highway System**

**WHEREAS**, the Vermilion County Highway Department and the Sidell Road District have agreed that the jurisdiction of South Sidell Road (CH-18), shall be transferred to Sidell Road District; and

**WHEREAS**, the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER", copy of which is attached hereto and made a part hereof, will effect the agreement for jurisdictional transfer of South Sidell Road (CH-18) according to the terms stated herein;

**NOW THEREFORE, BE IT RESOLVED** by the County Board of Vermilion County, Illinois that, subject to approval by the Illinois Department of Transportation,  
South Sidell Road, presently designated Vermilion County Highway 18 (FAS 513) as shown on the Jurisdictional Transfer Agreement, a distance of approximately 2.01 miles, be deleted from the highway system of Vermilion County, and

**BE IT FURTHER RESOLVED**, that the County Clerk is hereby directed to transmit four certified copies of the Resolution and upon execution, the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER", as executed by the County to the State of Illinois Department of Transportation, through its Region Engineer's Office at Paris, Illinois.
