WHEREAS, the Vermilion County Highway Department has requested the transfer of jurisdiction from the County to the Village of Sidell the section of roadway known as CH-18, (FAS 513) commencing at the south corporate limits of the Village of Sidell and proceeding northerly approximately 0.50 miles to the intersection of Dickson Street, FAS 514 in its entirety, and

WHEREAS, the Transportation Committee of the Vermilion County Board recommends that Vermilion County cooperate with the Village of Sidell in this roadway transfer, and

NOW THEREFORE, BE IT RESOLVED that the County Board Chairman, upon recommendation of the County Engineer, is hereby authorized and directed to execute on behalf of the County the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER" for the transfer of the above mentioned section of roadway, and


BE IT FURTHER RESOLVED, that the County Clerk is hereby directed to transmit four certified copies of the Resolution and upon execution, the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER", as executed by the County to the State of Illinois Department of Transportation, through its Region Engineer's Office at Paris, Illinois.

WHEREAS, the authority to make changes to the Township Road District System is granted to the Highway Commissioner under Section 6-201.3 of the Illinois Highway Code.
