

RESOLUTION

Re: Deletion of CH 18 within the Village of Fairmount from County Highway System

WHEREAS, the Vermilion County Highway Department and the Village of Fairmount have agreed that the jurisdiction of a portion of Sidell Fairmount Road (CH-18), shall be transferred to the Village of Fairmount; and

WHEREAS, the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER", copy of which is attached hereto and made a part hereof, will affect the agreement for jurisdictional transfer of a portion of Sidell Fairmount Road (CH-18) according to the terms stated herein;

NOW THEREFORE, BE IT RESOLVED by the County Board of Vermilion County, Illinois that, subject to approval by the Illinois Department of Transportation,
Sidell Fairmount Road, presently designated Vermilion County Highway 18 (FAS 513) as shown on the Jurisdictional Transfer Agreement, commencing at the south edge of Vance Street in the Village of Fairmount and proceeding southerly approximately 0.13 miles to the south corporate limits of the Village of Fairmount, in its entirety be deleted from the highway system of Vermilion County, and

BE IT FURTHER RESOLVED, that the County Clerk is hereby directed to transmit four certified copies of the Resolution and upon execution, the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER", as executed by the County to the State of Illinois Department of Transportation, through its Region Engineer's Office at Paris, Illinois.


