

## VERMILION COUNTY HEALTH DEPARTMENT

### Physician Agreement

This document is to confirm an agreement between the Vermilion County Health Department and WAMD TAZUJEN, M.D. Said physician is to act as the supervising Medical Director for the Vermilion County Health Department, providing medical services in accordance with all Vermilion County Board of Health policies and protocols as well as all applicable state and federal statutes, rules, regulations and standards of care.

#### Minimum Requirements

##### I. Education:

- A. Requires completion of courses in an approved medical school or completion of courses approved by the Educational Council for Foreign Medical Graduates supplemented by one (1) year of internship or its equivalent; and,
- B. Requires a license to practice medicine in all its branches in Illinois.

##### II. Experience:

- A. Requires clinical experience within three years prior to contractual employment by the Vermilion County Health Department in the practice of general or family practice medicine; or,
- B. Specialization in infectious disease control, or other clinically appropriate specialty.

#### Objective:

The supervising Medical Director is employed to function as a medical consultant during and outside regular clinic hours for the Public Health Administrator and staff.

#### Job Responsibilities

The supervising Medical Director shall:

- I. Function as a medical consultant for the review and development of appropriate and necessary medical/clinical protocols, policies and procedures.
- II. Provide technical consultation to staff providing services.
- III. Provides consultation regarding the appropriateness of test ordering and interpretation of test results.
- III. Review and approve standing orders.

Professional Liability

The clinic physician shall furnish to the Vermilion County Health Department and update as necessary: a copy of current MD license and a certificate of liability insurance because physician's professional liability insurance coverage is excluded from general liability coverage written for Vermilion County, Illinois.

Compensation

In consideration of the specific and general staffing requirements, described above, the supervising Medical Director and clinic physician shall be compensated for said services at a flat rate as follows;

\$833.33 per month for supervising medical issues, and providing requested consultations.

Terms of Employment

This agreement shall be effective for a period beginning August 1, 2020 through November 30, 2021. However, this agreement may be terminated by either party to the agreement by the delivery of written notice of termination at least 30 days prior to the effective termination date.
