#### Agenda Item 1- Call to Order and Roll Call

Also present were: Bill Donahue - County Board Risk Consultant, Cassy Carter - County Board Financial Administrative Manager, Doug Toole – Director of Health Department, Clayton Fauver – Health Department Finance Director, and Jim Russell – Director of Mental Health.

#### Agenda Item 2- Adoption/ Amendment to the Agenda

# Agenda Item 5 – Ordinance - RE: Amendment to the Combined Annual Budget and Appropriation Ordinance for the Vermilion County Health Department - \$435,000.00

Doug Toole advised that this is a state grant to cover mass COVID clinics. This amendment shows how the grant money will be spent. This is to cover mass vaccination clinics that will be scheduled for up to six days a week. This also covers: additional contact tracers, schedulers, nurses, EMTs, and additional services by the Sheriff's department for traffic control. Motion moved by Green, second by Frazier-Brenneman to approve. 

#### Regional Office of Education #54 Budget

June 14, 2021 Vermilion County Health and Education Committee

The FY22 ROE budget will have a decrease from the FY21 budget. The decrease will come from the salary line. The FY21 budget included additional funds due to the retirement of the office's long-time bookkeeper and side-by-side training with new staff before the retirement. Although the line has a decrease, salaries will increase by 3% for the ROE's three office staff members. Insurance rates have also been adjusted for FY22. Salaries and insurance increases do not include the Regional Superintendent and Asst. Regional Superintendent that are paid by the State of Illinois.

Supplies/Office remain the same at \$1,950.

Travel Expense remain the same at \$5,800.

Contractual/Communications is increased \$270 to cover ATT bill.

Postage was decreased \$240.

Publications remain the same at \$600.

Maintenance/Repair - Equipment remain the same at \$800

Contractual/Professional Services remain the same at \$10,200.

The contractual/professional services line covers the cost of Financial Preparations for the Office of the Audit General that is still required by code at this time.

I look forward to meeting with the Health and Education Committee this week to discuss the budget and any questions that you may have for me at this time.
