## AUTHORIZING A INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF DANVILLE, IL, AND COUNTY OF VERMILION, IL

## 2021 BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AWARD

This Agreement is made and entered into this 14th day of June, 2021, by and between THE COUNTY of VERMILION, acting by and through its governing body, the County Board, hereinafter referred to as COUNTY, and the CITY of DANVILLE, acting by and through its governing body, the City Council, hereinafter referred to as CITY, both of Vermilion County, State of Illinois:

WHEREAS, each governing body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each governing body finds that the performance of this Agreement is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services, functions or purchase of equipment under this agreement; and

WHEREAS, the CITY agrees to provide the COUNTY \$19,089.00 for the JAG award for the Overtime Program; and

WHEREAS, the Grant will be a joint grant between the City of Danville and Vermilion County.

## NOW, THEREFORE, THE PARTIES HEREUNTO AGREE as follows:

- 1. A joint application by the City of Danville and Vermilion County shall be submitted for the Edward Byrne Memorial Justice Assistance Grant.
- 2. The application seeks grant funds in the amount of \$43,384.00, which would be divided between the City of Danville and Vermilion County as set forth below.
- 3. The City of Danville shall act as the administrator of the grant and as the fiscal agent for any funds awarded.
- 4. Any funds awarded shall be distributed as follows: 56% to the City of Danville(with 3% going towards NIBRS compliance); 44% to Vermilion County (with 3% going towards NIBRS compliance). If the full amount of \$43,384.00 is awarded, the City of Danville will retain \$24,295.00 and disburse \$19,089.00 to Vermilion County.
- 5. Vermilion County shall provide quarterly expenditure reports, concerning the funds received pursuant to the grant.
- 6. Vermilion County shall provide annual progress reports, in narrative form, which outline the accomplishments, procurements, and activities associated with the grant funds.

- 7. Vermilion County shall provide any necessary information requested by the City of Danville to complete any required reporting to the granting agency.
- 8. Both the City and Vermilion County, as the sub-recipient, shall be required to comply with all special conditions of the Grant.
