# Agenda Item 1 - Call to Order and Roll Call

Chairman Larry Baughn, Jr. called the meeting to order at 5:00 PM. ## Agenda Item 5 – Redistricting Map Presentation by Dr. Mike Fortner

Upon introduction by Chairman Larry Baughn, a presentation by Dr. Michael Fortner was had concerning the required redistricting plan due December 31, 2021. Dr. Fortner indicated that there was a late completion and release of the Census for redistricting and as of now, in September there was released from the Census Bureau just enough information to complete the redistricting for the County. Dr. Fortner indicated the population changes required redistricting and leaving the current districts as is was not an option. Dr. Fortner explained that federal requirements and state requirements require weighing of certain factors and that he also had to be certain that any minority group that was of a certain percentage size of the population had to be accommodated to ensure at least one or two districts gave a fair opportunity for that minority group to elect candidates of their choice. Details of the presentation are in the attached report from Dr. Fortner, Asa result of those factors, Dr. Fortner came up with two options, Plan "A" and Plan "B" and both options tried to maintain the same general size and boundaries of current districts to give voters some degree of consistency while matching federal and state requirements given the population changes and the required attention to minority voting rights. Plan "A" concentrated on maintaining whole Townships while paying attention to the forgoing and Plan "B" concentrated on equality of population for each district while again paying attention to the requirements noted.

Board Member Mary Ellen Surprenant asked about the precise lines of a district boundary and that was clarified by Dr. Fortner. Board member Jerry Hawker asked about the process and information provided and Dr. Fortner clarified his reliance on population numbers, minority voting rights and the federal and state requirements.

# Agenda Item 7. Items of Information:

Baughn indicated that he received the report from Dr. Fortner on November 24, 2021 and set this meeting up for a presentation. A separate Executive Committee meeting would be had on December 16, 2021 at the same time and place as this meeting to vote on the possible two redistricting options, and followed then by a full County Board meeting on December 21, 2021 to have the full board vote on the redistricting plan. Either Plan "A" or Plan "B" could be ultimately chosen as the Board desires.

The scheduled Finance meeting for December will be cancelled due to lack of business for that meting given the newness of the current budget year which commenced December 1, 2021.
