### Agenda Item 1 - Call to Order and Roll Call

Committee Chairman Joe Eakle called the Transportation Committee of the Vermilion County Board to order at 5:00 p.m. Upon the call of roll, the following committee members were present: Joe Eakle, Mitch Weaver, Craig Golden, Robert Boyd and Shelley Mclain. Jerry Hawker and Diana Frazier-Brenneman were excused. 5 present and 2 Absent. Also attending the meeting: Adrian Greenwell- County Engineer, Larry Baughn Jr.- Chairman, William Donahue- Risk Consultant, and Jennifer Jenkins - County Board Office Manager.

### Agenda Item 2 - Adoption of the Agenda

## COUNTY-TOWNSHIP AID FOR BRIDGE CONSTRUCTION PROGRAM SECTION 5-501 DIVISION 5 – ROAD AND BRIDGE LAWS OF ILLINOIS

WHEREAS, under the provisions of Section 5/5-501 of the Road and Bridge Laws, Townships that have met all requirements of doing bridge or other work specified in Section 5/501 entitles them to petition the County Board to levy a sufficient sum to meet one half the expenses of the engineering, construction or repair of any bridge or other such work, on condition that said Township shall furnish the other half of the required amount, and,

TO: THE COUNTY BOARD OF VERMILION COUNTY, ILLINOIS.
