MINUTES

Agenda Item 1 - Call to Order and Roll Call

Committee Chairman Steve Fourez called the Finance & Personnel meeting to order at 5:00 PM. Upon the call of the roll, the following members were present; Steve Fourez, Wes Bieritz, Craig Golden, Mary Ellen Surprenant, Bruce Stark and Becky Stark. Excused absent was Crisi Walls. Also, in attendance; Larry Baughn – Vermilion County Board Chairman, Cassy Carter – Financial Resources Director, Bill Donahue – Risk Consultant, Erika Briggs – Auditor, Mike Marron – State Representative, Darren Duncan – Treasurer, Jerry Hawker – County Board Member, Tim Dudley – Vermilion Advantage, Doug Toole – Heath Department Administrator, Steve Brandy – WDAN and Nancy Boose – HR Director (via phone call).

Agenda Item 2 - Adoption/Amendments to the Agenda

He is frustrated with the management of the Lank Bank as well as feels they are pitting counties against each other. There was a bill going to Springfield regarding Land Bank, but he will hold that bill until this gets resolved.

Tim Dudley, CEO of Vermilion Advantage, stated that he echoed Marron's comments. There was a multi-million-dollar project that almost didn't happen in Vermilion County.

Darren Duncan, Vermilion County Treasurer, also agreed with the comments from Marron and Dudley. Duncan sits on the Land Bank board and stated that he urges the county not invest money in Land Bank until all issues are resolved.

Agenda Item 5 - Financial Update

Ms. Briggs reviewed the financial update that consisted of the General Fund Revenue document, and the Fund Equity Changes Report. Discussion ensued on fund balances. She explained all is looking well on Revenue since we are now two months into 2022. She also noted the ARPA report attachment.

The external auditor stated in October 2021 that the county could no longer pay the director via W-2. Going forward in 2022 this needs to be paid as a 1099 and to have them sign a W-9 to pay as a vendor. The Land bank has yet to sign the W-9, so we have been unable to pay for wages. The Chairman is looking for a way to resolve this issue. Chairman Baughn will move forward working with Wes Bieritz to resolve this issue.
