Agenda Item 1 - Call to Order and Roll Call

Agenda Item 4 - Audience Comments

Ed Butler from the NAACP and Reverend Frank McCullough presented a request for ARPA funds. The request for \$500,000 would help to renovate a building to teach troubled kids how to change their mindset. The goal is to keep kids off the street after school and give them a place to go until 10:30pm. They are planning to have areas for skating, gym, day room, DACC teaching, and a library. Nancy O'Kane and Jerry Hawker spoke up in favor of helping the Three Kings of Peace with this project.

Bruce Stark motioned, second by Craig Golden to discuss. Chairman Baughn explained this new as of 4/19/2022. The Sheriff salary is now set at 80% of the States Attorney. Since the state pays $66\frac{2}{3}\%$, this will save the county \$50,000 in the salary line.
