RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR THE PUBLIC DEFENDER'S OFFICE

WHEREAS, the Public Defender's Office requires additional funds to adjust the salary of the department head due to the State's Attorney's salary being modified by legislative COLA increases; and,

WHEREAS, by statute the Public Defender's salary is set at 90% of the State's Attorney's salary in order to receive a reimbursement from the State of 66% of the Public Defender's salary, and thus a savings of County funds, such that it is both appropriate policy and economical for the County to adhere to the statutory guidelines; and

WHEREAS, the budget therefore needs to be amended accordingly and this need was not known when the budget was prepared, and thus was not included.

NOW, THEREFORE BE IT ORDAINED by the County Board of Vermilion County Illinois that the County Auditor and County Board Chairman and Office be authorized and instructed to so amend the budget for fiscal year 2021-2022 as set out below:
