Dear Mr. Greenwell:

The resolution authorizing the transfer of \$61,400.00 of Surface Transportation Program (STP) funds for partial reimbursement of the Vermilion County Engineer's salary was approved by the department on August 8, 2022. A copy of the approved resolution is attached.

A warrant in the amount of the STP transfer will be issued to the County Treasurer and mailed to you by the State Comptroller's office in the near future. This warrant should be deposited in the county's Motor Fuel Tax account. We have assigned a section designation of 23-CS183-00-AC for use in monitoring the fund transfer. The section designation identifies the year "23" of the transfer, the "CS" indicates the transfer is for County Engineer's salary, "183" is your county number, and the "AC" identifies it as credit to the county's Motor Fuel Tax account.

For your reference, the agreement between the County and IDOT for participation in the salary program was executed on July 10, 2018 and expires on July 9, 2024.
