CIRCULAR LETTER 2022-26

REBUILD ILLINOIS BOND GRANTS SIXTH (6<sup>th</sup>) AND FINAL INSTALLMENT

COUNTY ENGINEERS / SUPERINTENDENTS OF HIGHWAYS / MUNICIPAL ENGINEERS / DIRECTORS OF PUBLIC WORKS / MAYORS / METROPOLITAN PLANNING ORGANIZATIONS – DIRECTORS / TOWNSHIP HIGHWAY COMMISSIONERS / CONSULTING ENGINEERS

The Illinois Department of Transportation (IDOT) is providing Local Public Agencies with the sixth (6<sup>th</sup>) and final, installment of the \$1.5 billion grant program from the local government component of the REBUILD ILLINOIS capital bill program. This sixth (6<sup>th</sup>) and final installment again consists of \$250 million that will be distributed based on the regular Motor Fuel Tax (MFT) formula. These \$250 million are not MFT distributions, rather they are grants made from bond sale proceeds that must be deposited into the Local Public Agencies' MFT account, and authorized and expended for transportation use with IDOT oversight.


This installment will be disbursed either through mailed checks or direct deposit from the Illinois Comptroller's Office, and Local Public Agencies can reach out to their district offices or the contact below if they have yet to receive their checks.

As a critical reminder, all allocated REBUILD Illinois bond funds must be obligated by no later than July 1<sup>st</sup>, 2025, which coincides with the end of the REBUILD Illinois Capital Program. Please work through your District Local Roads Team to pre-approve each RBI expenditure, submit the proper authorization forms, and to reconcile all of your authorizations, expenditures, and obligations well in advance of the deadline. The Department appreciates your attention on this matter.

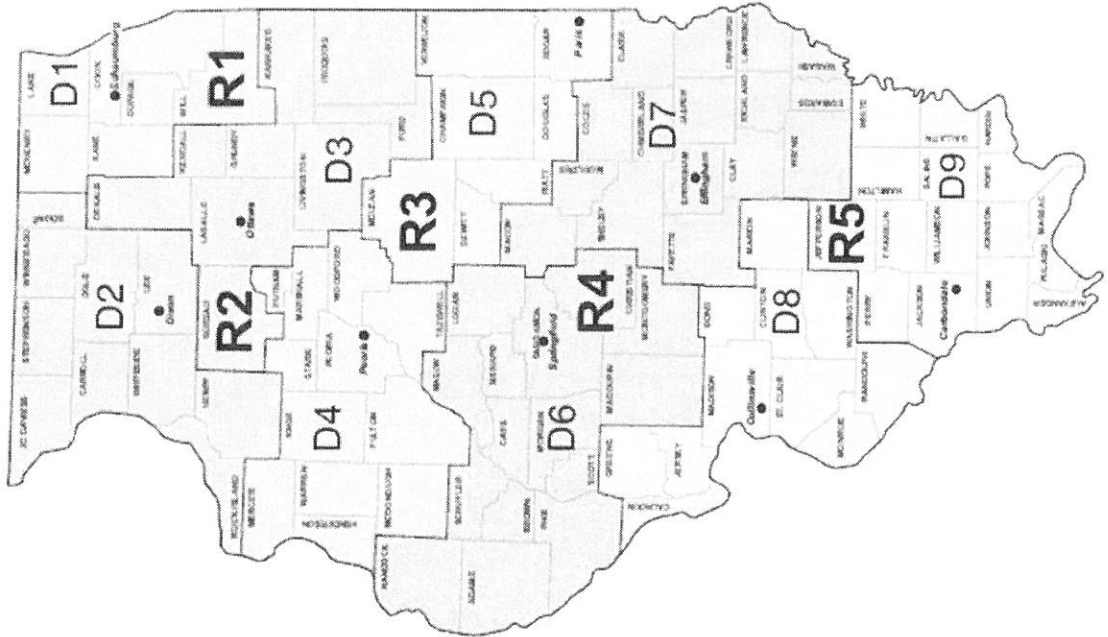
