

Minutes of the June 16, 2022 meeting of the Danville
Election Commission

1. Call to Order: The meeting was called to order at 9:00 am. By Chairperson Barbara Bailey
 2. Attendance: Present were Chairperson Barbara Bailey, Thomas Mellen, Secretary David Ryan, and Executive Director Sandra Delheye.
 3. Approval of Agenda: On motion of Thomas Mellen, seconded by David Ryan, the agenda was approved.
 4. Approval of Minutes: The minutes of the May 11, 2022 meeting were approved on motion of Barbara Bailey, seconded by Thomas Mellen.
 5. Public Comments: No public comments.
 6. Approval of Payables: On motion of David Ryan, seconded by Thomas Mellen, payables in the amount of \$7,268.06 were approved. Sandra Delheye indicated these payables included the cost of the voter drop box and supplies needed for the upcoming election
 7. Voter Registration Numbers/ May 2022: Sandra Delheye reported active voter registrations of 15,836 (a decrease of 95) and inactive registrations of 2,102 (an increase of 83). Sandra stated the changes were the result of the recent canvass.
 8. Commissioner comments: David Ryan stated he had voted early using the new touch screen equipment and found the system to be user friendly and found the staff was most helpful. Sandra reported that many early voters had positive reactions to the machines, and Barbara Baikley commented that the new system had been given good publicity locally.
 9. Director Comments: Sandra Delheye reported that her school visits had resulted in 8 new voter registrations. She noted that the change in the date for the primary from March had resulted in a few problems: several election judges will be unable to serve due to vacations and/or child care issues, and the 2 crews who helped with the delivery of voting equipment to the polls immediately before election day were both unavailable. Sandra had found replacements for the positions. Finally, Sandra expressed disappointment in Mayor Williams' negative response to the Commission's request for permission to install the voter drop box in a location on Harrison Street where it would be accessible to voters in their cars. The commissioners discussed alternatives and future courses of action.
6. Adjournment: On motion of Thomas Mellen, seconded by Barbara Bailey, the meeting was adjourned at 9:34 a.m.
