Agenda Item 1- Call to Order and Roll Call

Chairman Kevin Green called the Health & Education meeting to order at 5:00 pm. Agenda Item 2- Adoption/ Amendment to the Agenda

Green motioned to approve agenda with amendment to move agenda item number 12 of Executive Session, after Audience Comments. This was seconded by Miller.

Agenda Item 6 - Budget - Mental Health

Motion moved by Green, second by Miller to discuss. Baughn explained this was the same budget amount as last year with raises and the 3.25% increase in salaries. He also noted, since allowed by ARPA, we are paying some of the salary and insurance via the ARPA fund to allow the budget to be balanced.

Upon the call of the roll the following members voted yes, to wit: Kevin Green, Steve Miller, Phearn Butler and Larry Baugh. 4 yes, 3 absent. Motion passed

Agenda Item 7 – Budget – ROE

Motion moved by Green, second by Miller to discuss. Aaron Hird explained this was the same budget amount as last year with raises and the 3.25% increase in salaries. Miller expressed interest in the program, "I sing the body electric" and asked if Hird could look into bringing back.

Upon the call of the roll the following members voted yes, to wit: Kevin Green, Steve Miller, Phearn Butler and Larry Baugh. 4 yes, 3 absent. Motion passed

Agenda Item 8 - Budget - Health Department/Solid Waste

Motion moved by Green, second by Butler to discuss both budgets. Toole explained the budget was same as the previous year, plus raises and 3.25%, he also noted he will have two recycled dates.

Upon the call of the roll the following members voted yes, to wit: Kevin Green, Steve Miller, Phearn Butler and Larry Baugh. 4 yes, 3 absent. Motion passed

Agenda Item 9 - Ordinance - RE: Ordinance Amending the Vermilion County Food Sanitation Ordinance

Motion moved by Green, second by Miller to discuss. Toole explained this is to align the county code to match state code.

Upon the call of the roll the following members voted yes, to wit: Kevin Green, Steve Miller, Phearn Butler and Larry Baugh. 4 yes, 3 absent. Motion passed

Agenda Item 10 - Budget - Animal Regulations

Motion moved by Green, second by Miller to discuss. Snyder explained the budget was similar to last year with the exception of increase in salary line. They are receiving a raise and the 3.25%. Discussion ensued regarding various budget lines and the plan for the Animal Shelter with transfer from General Fund. Upon the call of the roll the following members voted yes, to wit: Kevin Green, Steve Miller, Phearn Butler and Larry Baugh. 4 yes, 3 absent. Motion passed

<u>Agenda Item 11 – Ordinance – RE: Amendment to the Combined Annual Budget and Appropriation</u> <u>Ordinance for the Animal Control Department - \$32,987</u>

Motion moved by Green, second by Butler to discuss. Snyder explained this is to care for the large number of animals at the shelter.

Upon the call of the roll the following members voted yes, to wit: Kevin Green, Steve Miller, Phearn Butler and Larry Baugh. 4 yes, 3 absent. Motion passed

Agenda Item 12 - Discussion - Animal Shelter

Chairman Green introduced the topic, county board member Jerry Hawker asked questions regarding the shelter and specific lines of the budget. Discussion ensued on both issues.
