In counties over 500,000 population and in jurisdictions under a Board of Election Commissioners, two supporting affidavits are required. (10 ILCS 5/5-29, 6-66). In other jurisdictions, one supporting affidavit is required. (10 ILCS 5/4-22)

4. Assisted Voter I cannot read or write the English language and hereby request assistance. (10 ILCS 5/7-48, 17-14). One assisted voter affidavit is required.

5. Assisted Voter By reason of a physical disability of _____, I am unable to mark my ballot and hereby request assistance. (10 ILCS 5/7-48, 17-14). One assisted voter affidavit is required.

6. Vote By Mail Ballot not received by Voter I applied for but never received a vote by mail ballot (10 ILCS 5/17-9, 18-5).

7. Vote By Mail Ballot not received by Election Authority I completed and returned a vote by mail ballot and was informed that the election authority did not receive my vote by mail ballot. (10 ILCS 5/17-9, 18-5)

8. Residence not changed, 9-1-1 address change I have not moved, but my address has changed because of the implementation of a 9-1-1 emergency telephone system. (10 ILCS 5/17-10)
Two forms of valid identification are required and both must show the voter's current residence address, or proof of the voter's in-precinct residence may be established by a qualified witness. (10 ILCS 5/17-10)
