

RESOLUTION

RE: Jurisdictional Transfer of Gravat Road (CH 30) to Blount Road District

WHEREAS, the Vermilion County Highway Department has requested the transfer of jurisdiction from the County to Blount Road District the section of roadway known as Gravat Road (CH 30), FAS 1508 & FAU 7027, from the east edge of pavement of Henning Road, easterly to west edge of pavement of Denmark Road, in its entirety, and

WHEREAS, the Transportation Committee of the Vermilion County Board recommends that Vermilion County cooperate with the Blount Road District in this roadway transfer, and

WHEARAS, upon IDOT approval CH 30 designation will be removed from the transferred jurisdiction;

NOW THEREFORE, BE IT RESOLVED that the County Board Chairman, upon recommendation of the County Engineer, is hereby authorized and directed to execute on behalf of the County the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER" for the transfer of the abovementioned section of roadway, and

BE IT FURTHER RESOLVED, that the County Clerk is hereby directed to transmit four certified copies of the Resolution and upon execution, the "LOCAL AGENCY AGREEMENT FOR JURISDICTIONAL TRANSFER", as executed by the County to the State of Illinois Department of Transportation, through its Regional Engineer's Office at Paris, Illinois.
